

ASSEMBLY OF CROSS-BARS

1. Ensure the roof is clean, free from dust and grease.

2. Insert the neck of the End-Support into the void of the Cross-bar profile. They are designed to be a tight fit: use a rubber mallet if necessary (Fig.1)

3. Pull back the rubber Buffer Strip about 20mm until the screw hole can be accessed.(Fig. 2) Using a Phillips Head Screwdriver, fasten the screw through the cross-bar and into the End Support.

Do this for all four sides and replace the buffer strip.

NOTE: The longer cross-bars are to be fitted to the front of the vehicle. Check labelling on the underside of the cross-bar.

FITTING CROSS-BARS TO VEHICLE

4. Open all 4 vehicle doors and carefully pull back the weather seal to reveal the Horizontal Body Flange (Fig. 4b)

5. Engage the locking straps on the flange with the centreline of each position to the dimensions shown in Fig.4a, relative to the door joint at the B-Pillar.

6. Slide the mount pads under the locking strap with the pointier end towards the front of the vehicle for the rear pads and revers for the front as shown in Fig.4a. This is done so that the crossbar does not appear in the middle of the sunroof when open (if fitted to your particular vehicle).

7. Place the respective crossbar assembly onto the mount pads with the sloping face of the End support towards the front of the vehicle for the rear crossbars and reverse for the front crossbars.

8. Loosely fit the special bolt through the end support and into the locking strap cage nut. Give two or three turns of bolt in cage nut with key provided (Fig.5).

9. Go to the other side of the vehicle. Pull on the end support and fit using the same technique as above. This will allow for correct alignment of the cage nut and bolt thread.

Note: Leave a gap of approximately 3 to 5mm between the bottom of End Support and the top of the Strap bracket(Fig. 9). Over-tightening the bolts may result in damage to your vehicle and/or roof-rack.

10. Replace the weather seal.


11. Proceed to follow steps 5 to 10 when mounting the Rear Cross-bar Assy.

FINAL CHECK

Both crossbars should be square to the fore and aft axis of the vehicle and be parallel to each other. Check all of the bolts again after loading and the the straps are engaged securely.

12. You are now ready to mount your "Accessories" set onto the cross-bars using the Global Mount Channel. Once installed, insert the 'Global Channel' Covers into the End Supports.

Note: You have a choice of 2 - (a) quick access snap-on cover or (b) long term mounting - security cover to cap off and lock the mount channel. (Fig. 6)

General Usage Information

It is essential for the proper assembly, operation and use of the Roof Rack that the instructions and safety precautions supplied are strictly observed. Read any fitting, care and usage instruction carefully.

The maximum permissible load for your Roof Bar is the lower of the maximum load capacity specified in your vehicle operation manual, or specified as applying to the Roof-Rack. Do not exceed the maximum specified load capacity. Maximum permissible load = weight of the Roof Rack + weight of accessories + weight of load (cargo).

When fitting the Roof-Rack and transporting a load, ensure the vehicle's functions are not impaired (eg, sunroof, aerials, windscreen wipers, mirrors). Rear doors on Hatch- and Wagon-type vehicles should be inspected for adequate clearance for full opening operation of the boot/tailgate.

Stop and check all screw connections, bolts and retaining straps after a short distance of travel. Repeat these checks at regular intervals.

Warnings

Remember that the fitting of a Roof Rack and the transport of a load increases the overall height of the carrying vehicle.

Where the Roof-Rack is to be used in off-road conditions, a safety weight reduction of 1.5 should be observed from the total carrying capacity. (eg. 60kg becomes 40kg)
