Step-By-Step Instructions

Warning:

Safety First: Always use correct safety equipment.

This towbar is NOT to be drilled, cut, welded or modified in any way.

Check the surrounding area before drilling into chassis or body panels for fuel lines, wiring harnesses and other components that may be a hazard.

General:

Before fitting this towbar read fitting instructions and check installation hardware is correct.

Check that the towbar is suitable for the vehicle and be wary of any changes to the vehicle design that may conflict with the fitting of this towbar.

After drilling, blow any filings clear, remove any swarf and treat exposed metal with a rust inhibitor.

If this vehicle requires a bumper cut out, please check to make sure that you measure twice and check twice before cutting any panels as some bumper profiles can change.

If you are not sure then ask your towbar supplier.

Tighten all bolts as specified on the last page.

1. Unbolt hardware from tow bar.
2. Offer tow bar to vehicle and loosely fit M14 x 40mm bolts through sides.
3. Feed bolts on wire down chassis rails and offer mount plate to under side of chassis and loosely fit forward most spring washer and nut, both sides. Add 3mm packer plates to the remaining 2x bolts and lift mount plate into place then fit spring washers and nuts both sides.
4. Fit 5mm packer plate between end plate and mount plate then fit 2 x ½" bolts each side through tow bar packer plate and mount plate.
5. Tighten all hardware and cut off excess wire from bolts on wire.
